INTRODUCTION

Association of Asian Confederation of Credit Unions (ACCU) operates as a regional representative organization of credit unions and similar cooperative financial institutions in the region of Asia.

As of June 2010, ACCU has 14 regular members, 1 associate members, 15 Affiliate members and 35 supporter members from 22 countries.

A team of Competent human resources carries out the implementation of work plan under each of the following divisions: Planning and Development, Member Services, Promotion, Marketing and Research, Business Development, and Support Services.

As a regional organization of credit union leagues and federations, representing 22 countries in the Asia region, ACCU has a unique and diverse skill in the development of, promotion of, and strengthening of credit unions in different stages of development.

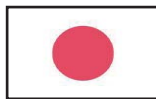
